







Market Update: 14th September 2022

Autumn 2022 Market Consultation for MetroLink design-build contract packages for core infrastructure

On 16th April 2022, Transport Infrastructure Ireland (TII) published a Prior Indicative Notice (PIN) in the OJEU (TED Reference: 2022/S 076-208843) and on the eTenders website, etenders.gov.ie - System ID 212034 and <u>link</u>; TII Tender Reference TII150_01). This PIN launched TII's Spring market consultation on the proposed PPP project and included for further consultations on the continued development of the three main design-build contract packages for the core infrastructure.

It also required that all parties previously registered under Tender Reference TII150 published on eTenders on 9th November 2019 ("Market Consultation Relating to the Procurement of Design, Construction, Delivery, Maintenance and Operations of Dublin Metrolink"; TED Reference: 2019/S 218-536230 and eTenders system ID 159996) re-register their interest with TII, whether or not they wished to engage in the market consultation for the MetroLink PPP project.

TII is now undertaking a market consultation exercise on the design-build contract packages. The purpose of the consultation is to inform the market of the current contracting approach proposed by TII and to seek feedback on the technical, contractual and commercial aspects of the project. These contract packages comprise the main civil engineering works required for the Project, including the tunnelling works in the southern and central sections of the works and associated deep stations along the route, surface works and stations, the bridge crossing of the M50 motorway and the viaduct crossing at Broadmeadows.

Any interested parties wishing to respond to this market consultation, whether or not they responded to any earlier consultations and are already registered with TII to receive Market Updates, are required to send a request via the e-tenders messaging portal to the contact person named in the notice seeking to be issued with a copy of the briefing pack for review and completion of the questionnaire contained within the pack. Following receipt of the briefing pack, the subsequent closing date for responses to the market consultation is 12 noon on Wednesday 28th September 2022.

Participants to the recent consultation on the proposed PPP contract package are welcome to receive this information pack and questionnaire and to submit any observations on the proposed civil engineering packages.

Further, any registered party who did not participate in the consultation on the PPP contract package and who would like to do so should send a request via the e-tenders messaging portal to the contact person named in the notice seeking to be issued with a copy of the briefing pack for review and questionnaire for the PPP contract package and submit their response by 12 noon on Wednesday 28th September 2022.

All correspondence will be via the eTenders Messaging portal including the issuing and response to the Market Consultation pack.
